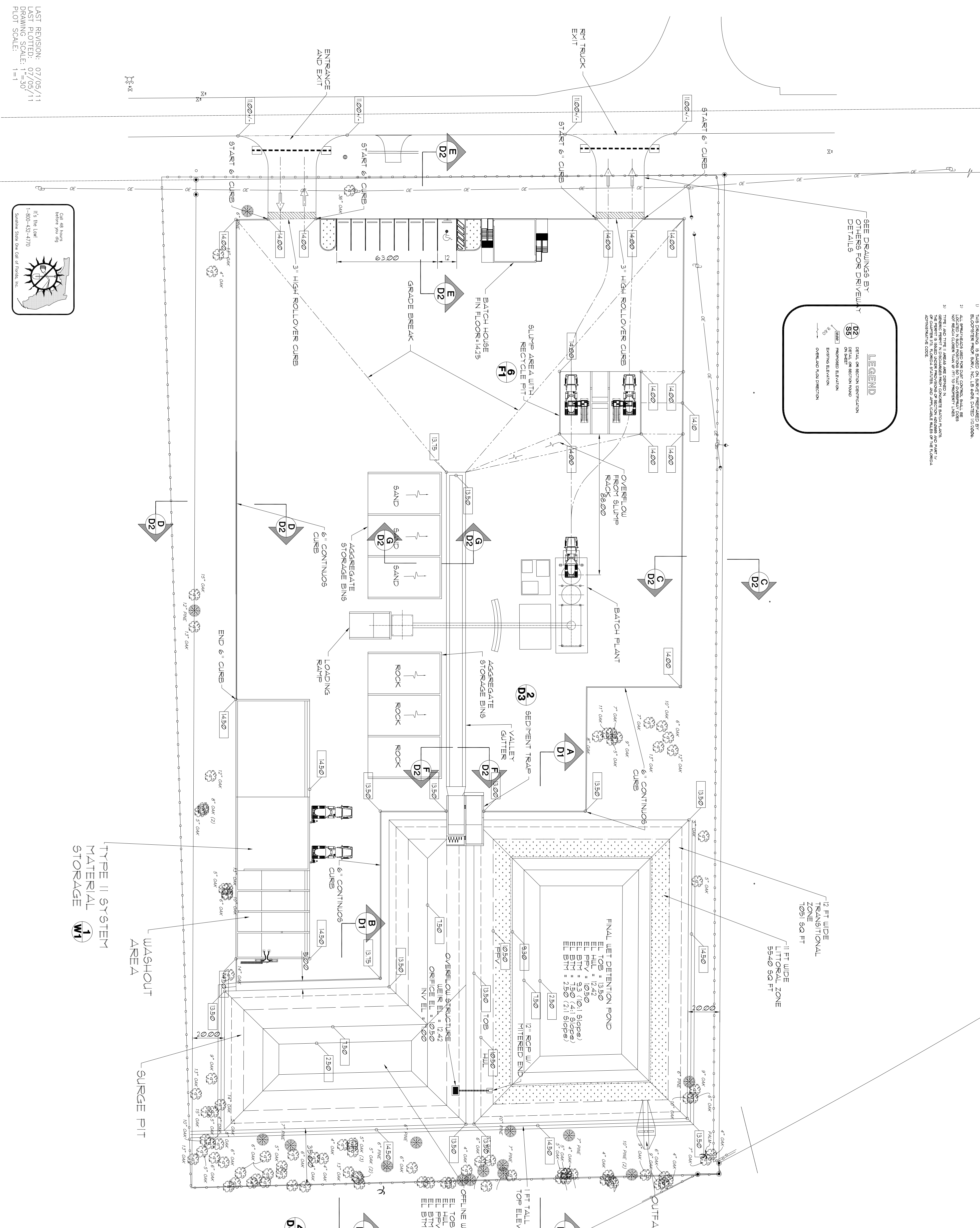
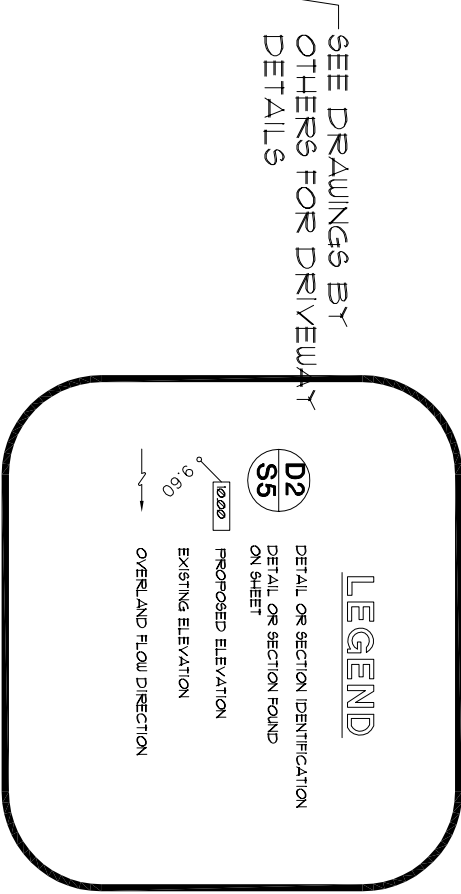


**MISC. NOTES**
